Current IJF contest rules with the following modifications:

Pre 1994 contest rules regarding safety zone and out of bound area. True double elimination in divisions having 6 or more competitors. Divisions having five or less competitors, whereby, it will be run as a round robin.

Kansetsu-waza (arm locks) will be allowed in BROWN AND BLACK BELT DIVISIONS.

Yonen (Male and Female from 5 to 12 years old)

1. Match time: 2 1/2 minutes
2. No Shime-waza (chokes)
3. No Kansetsu-waza (arm locks)

Shonen (Male and Female from 13 to 16 years old)

1. Match time: 3 minutes
2. No Kansetsu-waza (arm locks)
3. No Black belts

Seinen (Male and Female from 17 years old and older) Novice Division

1. Match time: 3 minutes
2. Under the rank of brown belt
3. No Kansetsu-waza (arm locks)

Kansetsu-waza (arm locks) will be allowed in BROWN AND BLACK BELT DIVISIONS.

Shonen – Seinen (Male and Female) BROWN BELT DIVISION

1. Match time: 4 minutes
2. No contestant under the rank of Sankyu

Shonen- Seinen BLACK BELT DIVISION

1. Match time: 4 minutes
2. IJF RULES REGARDLESS OF RANK OR AGE

Masters – Male above the Age: 35 – 49 & Age: 50+

1. Match time: 3 minutes

In consideration of being permitted to participate in any way, including travel to and from in any Judo tournament, practice, clinic, and related events and activities (“Activity”) of the **United States Judo Federation, Inc., USA Judo/United States Judo, Inc., United States Judo Association, Inc., Pacific Southwest Judo Association, Esther Snyder Community Center, and the Migoto Judo Club**, I agree:

1. I understand the nature of Judo activities and believe I am qualified to participate in such Activity. I also understand the rules governing the sport of Judo.
2. I further acknowledge that prior to participating, I will inspect the mats, equipment, facilities, competition pools or divisions, and the elimination or scoring system to be used, and if I believe anything is unsafe or beyond my capability, I will immediately advise my coach, supervisor, and/or a tournament official of such conditions and refuse to participate.
3. I acknowledge and fully understand that I will be engaging in a contact sport that might result in serious injury, illness or disease, including permanent disability or death, and severe social and economic losses due not only to my own actions, inactions or negligence, but also to the actions, inactions, or negligence of others, the rules of the sport of Judo, or conditions of the premises or of any equipment used.
